
MEMBER NEWS

IRS RAISES OPTIONAL MILEAGE RATE

The optional standard mileage rate used by the IRS for deducting business expenses was raised from 27.5 cents to 28 cents effective January 1, 1992. In addition to the optional mileage rate, taxpayers can still deduct parking fees and tolls. There no changes in the 12 cents per mile deduction for charitable travel or the 9 cents per mile deduction for moving and medical expenses.

"THE FEMALE ADVANTAGE"

I recently read a book by Sally Helgesen entitled "The Female Advantage - Women's Ways of Leadership." Helgesen spent an entire day each with four very successful leaders researching their strategies and organization theories, creating "diaries" about them. The four women were Frances Hesselbein, National Executive Director of the Girl Scouts; Barbara Grogan, President of Western Industrial Contractors (Denver, Colorado); Nancy Badore, Director of Ford Motor Company's Executive Development Center; and Dorothy Brunson, President of Brunson Communications.

The studies showed that women have different methods of leadership. The women studied seemed to be in the center of things, as in a circle or web looking out, rather than at the top, looking down. In 1968 a study was done on five successful male leaders by the management scientist Henry Mintzberg. Helgesen found the following similarities and differences between the men and women studied in the two groups: (1) The women scheduled small breaks throughout the day while continuing to work at a steady pace. The men did not schedule in such breaks, but worked at an unrelenting pace. (2) The women did not view unscheduled encounters and tasks as interruptions, while the men looked at anything that wasn't on their schedule as an interruption and thus their days were very fragmented. (3) While the men spared very little time for activities not directly related to work, the women made time for such activities. (4) Although both the men and women preferred live action encounters, the men looked on answering the mail as relatively unimportant whereas the women scheduled time to answer it. (5) Both the men and women maintained a complex network of relationships outside their business. (6) The men were involved in the day-to-day running of their companies, with no time for reflection, while the women tended to focus on the long range. (7) The women saw themselves as complex and multifacted individuals while the men identified themselves with their jobs. (8) The men had difficulty sharing information while the women actually scheduled in time for such sharing.

The jacket on the book cover indicated that Helgesen shows in her studies, "how workplaces run by women tend to be 'webs of inclusion' - communities where sharing information is key, where the rules of the hierarchy come undone in unexpected points of contact. And while male leaders tend to champion the value of vision, women leaders concentrate on developing a voice." The feminine principles noted in the book appear to be the management style of the 90's. And according to our speaker at the April meeting, the old (i.e., men's) method of management is on its way out and the women's way is coming in. This is a very interesting book and I would highly recommend it. Not only is it thought provoking, but entertaining as well.


