

# WHAT IT TAKES TO BE A LEADER

Pam Vokolek, the Public Relations Officer for the City of Ames, was the speaker at the June 10th Membership Meeting. She noted that there are many kinds of leaders. To be a successful leader, you need to have the three "G's": Goals, Game plan, and Gumption. Everyone has the ability to be a leader. It just must be tapped correctly.

One of the most beneficial leadership programs is the one which has been developed for large cities. The Leadership Ames program is six years old and is under the auspices of the Chamber of Commerce. It involves a big time commitment (one day a month) from August through April. There are 15 to 17 people in a class and represent a good cross-section of people from the community. Each member must be approved by a committee of the Chamber and each group must complete a project of some sort.

Applications for the next class of Leadership Ames are being accepted during the month of August. Why not consider developing your leadership skills by applying now? In addition, once Leadership Ames has been completed, you can apply for the Leadership Iowa program.

Pat Eich will be moving to Columbia, Missouri, in August with her family. Good luck to you, Pat, and we will miss you. Keep in touch.


