

Minutes: On motion made by Karen Jacobson, seconded by Brenda O'Neall-Smith, motion carried unanimously that the minutes for the June 9, 1994, meeting be approved as printed in the Bulletin.

Treasurer's Report: None

COMMITTEE REPORTS:

<u>Bulletin:</u> The deadline for the next bulletin is August 20. The efforts to produce the bulletin were acknowledged. Volunteers were solicited to sponsor the bulletin for a month (approximate cost of \$35).

Membership: The Board approved the application for membership of Diane Duvall, subject to approval by National. Please give prospective member's names to Karen Jacobson. Kate Mulder will be working on the membership list. Program: Anyone with program ideas should give them to Brenda O'Neall-Smith.

<u>Public Relations:</u> We discussed whether to continue participating in the Meals on Wheels program. We have volunteers for September (Margaret), October (Diane), and November (Brenda). We will continue until the end of the year but reevaluate in October or November. We will look into the possibility of participating in career days at local schools to increase visibility.

OLD BUSINESS:

Speaker Gifts: The business card holders have been ordered by Jan. A total of 25 were ordered. They should be here for our next meeting.

Review of Objectives: Our 1994 chapter objectives were discussed. These are: 1. increase membership 50% (6), 2. membership attendance of 66% at meeting (8), and 3. increase chapter visibility.

NEW BUSINESS:

Recommendation on Public Relations Dinner: The membership discussed the possibility of not having a public relations dinner this year due to lack of funds. Nancy Campbell moved and Karen Jacobson seconded that we not have a public relations dinner as we have know it this year. This motion was passed unanimously. Brenda O'Neall-Smith moved and Kate Mulder second that we move the scholarship dinner to April, make it more formal, and invite guests. This motion also passed unanimously.


Member Profile: We should have a booklet out by next meeting of member information. This will also include member responsibilities, dates of meetings, and chapter objectives.

Network Luncheons: We discussed whether to continue the networking luncheons since there is no hospitality chair and these have not been well attended. In August, it will be at Hickory Park; in September, at the Mandarin.

ANNOUNCEMENT: We discussed the possibility of having the meetings at the same place each month. Not many restaurants were receptive to the idea so we will continue to have someone be responsible each month to find a place for their particular month. The National convention is in October. We will need to vote in September if we plan to send any delegates. The garage sale is tentatively scheduled for Saturday, September 17 at Jan Duffy's hours. Please bring items pre-priced.

ADJOURNMENT: On motion made by Karen Jacobson and seconded by Brenda O'Neall-Smith, motion carried unanimously that the meeting be adjourned at 7:30 p.m.
