# The Internet and You by Jan Duffy

Since I don't really have anything to fill up the rest of this page with, (I'm probably forgetting something vital), I thought I would let everyone know a liitle bit about ways in which I have been using the Internet. I know some of you are considering getting Internet access where you work. I have had it here for several months now, and spend quite a bit of time with it.

One use is finding out about other companies. I have found the SEC's Edgar Data base to be very useful. My classes are required to get actual financial statements, and all SEC filings are on line here. Also, many companies have their annual reports and quarterly data on their "home pages". If you want to look at ways various organizations are reporting financial and other information, the internet can be quite valuable.

There are many services that report stock market information as well. You can get quotes on stocks, and a coworker even has a screen saver that shows a ticker for stocks he preselects. This was downloaded from the internet.

Finally, there are a million personal uses for the internet. I have found vacation condos in Hawaii, checked NFL injury reports, tried to trade Garth Brooks tickets, and reserved hotel rooms. As you can tell from this list, one thing to consider in your acquisition decision is how to limit usage to business purposes. While this issue may be perplexing, I have found the net to be a valuable resource personally and professionally. If you haven't tried it, I would encourage you to do so.
