And how important it is to sometimes be able to recapture the mystery and delight of our first success with those tasks as a reminder to ourselves and to be able to share what we've learned with someone.

How great it is that we can concentrate and focus so we're not driven batty by trivial distractions. And how important it is that we sometimes let those distractions in and welcome what we can learn from them about ourselves and our processes.
