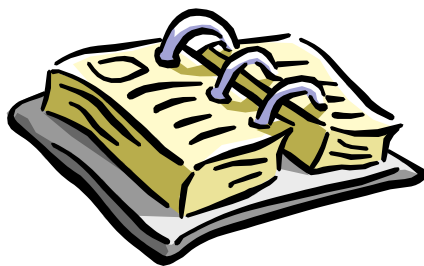
Speaker Information

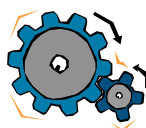

Ms. Sippel served the chapter this year in many ways. She served as Past President, chair of the nominating committee, co-chair of the chapter seminar task force, keeper of the name tags, arranger of car pools, social secretary, and substitute recording secretary. Ms. Sippel's past service to the Chapter has been distinguished as well. She has held many offices, is almost always on the chapter Board, has represented the Chapter at National ASWA meetings, and has been on many ad-hoc committees.

Strum receives public service award from statewide CPA association

WEST DES MOINES – The Iowa Society of Certified Public Accountants (ISCPA) has named Kathleen M. Strum, CPA, Nevada, as the recipient of the ISCPA Public Service Award for 2005. Strum is controller, director, and officer for Hertz Farm Management, Inc., a group of management and investment companies headquartered in Nevada.

Strum's public service has been with the following organizations:

- **American Society of Women Accountants** – Strum has most recently served as the credentials chair for the 2004 national convention. She also currently serves as a national board member for the American Society's educational foundation, which provides scholarships for women and men pursuing careers in accounting. Locally, she has served the organization as president, secretary, and treasurer, in addition to chairing and serving on numerous committees.
- **Rotary International** – Strum served as District 6000 treasurer in 2003-2004 and as the Nevada Club treasurer in 1994 and secretary/treasurer in 1995 and 1996. She volunteers for the Rotary Literacy Program for elementary school students and, for the past four years, as a mentor for elementary school students for the Youth and Shelter Services program. She is currently mentoring two students.
- **Ward One** – Strum served as City Council Person for the City of Nevada from 1997-2003. During that time, she also served as Gates Hall Board of Control member, overseeing the operations and \$1 million renovation of the hall, Nevada's community center.
- **National Kidney Foundation** – Strum has helped organize and participated in fundraisers which helped teams go to the 2002 Orlando and 2004 Minneapolis U.S Transplant Games. She has participated in activities to help raise organ donor awareness. In addition, she is a

past volunteer for United Way of Story County, serving on its Special Activities Committee from 2000-2003.
