# **Speaker Information**

**Dr. Sue Ravenscroft** moved to Iowa State University fall of 1998, after teaching at Eastern Michigan University for ten years. Her research has been published in The Accounting Review, Journal of Applied Psychology, Organizational Behavior and Human Decision Processes, Behavioral Research in Accounting, Advances in Management Accounting, Issues in Accounting Education, Journal of Accounting Education, and other journals. In addition, she has presented numerous papers at national and regional meetings. She has spoken on panels on business ethics and service learning at national accounting meetings. She has received the Excellence in Research Award at ISU (2000) and received a similar award earlier at Eastern Michigan University (1994). Currently she is serving as editor for Issues in Accounting Education and is on the editorial board of Behavioral Research in Accounting and Advances in Public Interest Accounting. She has worked for Peat Marwick Mitchell (now organized as KPMG) and is a CPA in the state of Iowa.

**Brett Blanchfield** is a Certified Real Estate Property Appraiser with Hertz Farm Management, Inc. in Nevada, Iowa. Brett joined Hertz Appraisal Services in May 2003 providing his expertise in appraisals at the Nevada office. Brett received a B.S. in Agriculture Economics with emphasis in farm and ranch management from the University of Nebraska in May 1998.

Brett has experience in commercial, farm and condemnation appraisals in Iowa, Kansas and Missouri. He assisted with his dad's farm and independent appraisal business for three years after graduating from the University of Nebraska. Brett then gained more experience working for Appraisal Associates in Kansas City, Missouri, followed by Keller & Associates in Lawrence, Kansas.

Brett was raised on a farm near Churdan, Iowa and attended Union College in Lincoln, Nebraska, for two years. In May 1998, he received his Bachelors degree from the University of Nebraska in Agriculture Economics with an emphasis in Farm and Ranch Management.

Brett has also taken numerous courses towards his Master's of Agronomy from Iowa State University (nutrient management, soils, weeds, pests and weather).

Ames Chapter #158 Membership Meeting September 21, 2005

- **Call to Order:** The September 2005 Membership Meeting of the Ames Chapter #158 was called to order by President Theresa Samson in Ames on Wednesday, September 21 at 7:32 pm. Those in attendance were Carolyn Bauer, Nancy Campbell, Karen Jacobson, Kate Mulder, Margaret Munson, Kathy Strum, Sue Rybolt, Mary Mosiman, Theresa Samson, and Cindy Sippel. A quorum was present.
- **Minutes:** There was one correction to the June minutes as presented in the bulletin. Karen Jacobson moved and Kate Mulder seconded that the minutes be approved as amended. Motion carried.
- **Treasurer's Report:** Treasurer's report for September was presented and will be placed on file for review.

#### **Committee Reports:**

**Membership Committee:** We discussed the possibility of using the November meeting for a membership drive where all members would be encouraged to bring a guest and the topic would be a Social Security reform discussion. The program and membership committees will meet to discuss plans for a membership meeting.

**Program Committee:** The October meeting will be a joint meeting with the Des Moines chapter to be held in Ankeny. The meeting will be on Wednesday, October 19 (our regular meeting night).

#### National Conference in Philadelphia

**ASWA Education Foundation (ASWAEF) Contribution** – Typically our chapter has donated \$10 per member to the education foundation. For 2005, that would be a donation of \$250. Karen Jacobson moved and Margaret Munson seconded a motion that we donate that amount. The motion passed. The chapter also discussed a basket/auction donation and how these kinds of donations have not always brought as much money as the item donated. A motion was made by Kathy Strum and seconded by Nancy Campbell that our chapter donate an additional \$50 to the education foundation in lieu of an auction item this year. The motion passed. The donation will be made in honor of Kate Mulder our member on the national Board of Directors.

**Bylaws Amendments** – Two bylaws amendments will be discussed and voted on at the National Conference. The group decided to make a recommendation for each amendment separately. The first amendment concerned the amount of members that would be needed to charter a new chapter. Currently a group of 30 or more members are required to begin a new chapter. The proposed amendment would allow for a smaller group along with some additional requirements. A motion was made by Kathy Strum and seconded by Sue Rybolt that our delegate (Karen Jacobson) is sent with an informed (as opposed to instructed) position regarding this amendment. The motion passed. The second amendment concerned the make up of the National Board. The Board is currently composed of 15 members. The proposed amendment would allow for a board of 14 as the largest and 9 as the smallest. Margaret Munson made a motion, which was seconded by Cindy Sippel that we send our delegate informed on this amendment also. The motion passed.
