Approval of Minutes: The June minutes were changed to fix a typing error in a members name from "Penney Strum" to "Penny Strum." The September minutes were changed to fix a typing error under Announcements from "wee" to week." It was moved by Karen Jacobson and seconded by Jan Duffy that the minutes be approved as amended. Motion passed.

Treasurer's Report: Dominique Bryant presented Treasurer's reports for September and October 2007. The Treasurer's reports were placed on file for review. Ann Kurtenbach asked for discussion of the 2007/2008 budget.

- Jan Duffy made the motion to increase the amount of scholarships up to \$2,500 from \$1,200 and seconded by Teresa Samson. Cheryl Carlile moved to amend the amount for scholarships to \$2,600 and Jan Duffy seconded. Motion passed.

- Jan Duffy reported that no members have attended the scheduled athletic events so no future dates will be set for members to attend.
- Karen Jacobson reported that there are currently 4 new members out of 8 new members needed for a free registration for a first time attendant to Nationals in October 2008.

Program: Donna Gladon announced Kristy Maitre from the Internal Revenue Service will speak at the next scheduled membership meeting.
