Article III, Section1.D.1.a. b. & c. – Qualifications:

- b. Retired from all gainful employment due to disability; or
- c. Age fifty-five or older and retired from all gainful employment and a regular or associate member for the shorter of ten consecutive years or the life of the chapter.

#### **Proposed Amendment**

 a. Age sixty-five or older, retired, and a regular member for ten consecutive years.

## Proposed Amendment #1:

To clarify and better define those members eligible to be a retired member. With a mobile society members may move to various chapters during their lifetime. Retired status should be relevant to membership in the organization, not to a specific chapter. The retired member will still pay Chapter Dues according to their Chapter Bylaws.
